The Eighth CCM Forum, sponsored by the American Meteorological Society, and organized by the AMS Board of Certified Consulting Meteorologists, will be held 7 January 2015, as part of the 95th AMS Annual Meeting in Phoenix, Arizona. Preliminary programs, registration, hotel, and general information will be posted on the AMS Web site (http://www.ametsoc.org/meet/annual/) in late-September 2014.

The theme for the 2015 AMS Annual Meeting is "Fulfilling the Vision of Weather, Water, Climate Information for Every Need, Time, and Place." Although this need is often fulfilled by governmental agencies and larger private sector companies, smaller private sector companies and individuals are coming more to the forefront in providing specialized forecasting and consulting services. However, CCM's (especially those who own and operate small businesses) may not be as well versed in all of the ramifications involved in business matters: type of business model (e.g., LLC versus sole proprietorship, Chapter C versus sub-S), accounting and billing procedures, employment contracts, taxes, insurance (Including errors and omissions), benefits, governmental regulations, marketing, web site development and use, the value of the CCM (for potential CCM candidates) and much more.

A half-day forum entitled, "The behind the scenes, nuts and bolts, of running a CCM business" is planned in which CCMs and other experts in business operations will share their experiences in running a business. Presentations will include advice and counsel, experiential sharing and panels addressing specific areas involved in running a business. The goal of the forum will be to make any CCM who runs a business better able to make that business run effectively and successfully as it provides services to a growing client base.

The \$95 abstract fee includes the submission of your abstract, the posting of your extended abstract, and the uploading and recording of your archived presentation on the AMS Web site. Please submit your abstract electronically via the Web by 1 August 2014 (refer to the AMS Web page at https://ams.confex.com/ ams/95Annual/oasys.epl. An abstract fee of \$95 (payable by credit card or purchase order) is charged at the time of submission (refundable only if abstract is not accepted).

Authors of accepted presentations will be notified via e -mail by late-September 2014. All extended abstracts are to be submitted electronically and will be available on-line via the Web. Instructions for formatting extended abstracts will be posted on the AMS Web site. Authors have the option to submit manuscripts (up to 10 MB) electronically by 6 March 2015. All abstracts, extended abstracts and presentations will be available on the AMS Web site at no cost.

NSF EarthCube

<u>NSF EarthCube</u> will create an integrated data management infrastructure across the Geosciences that will provide easy access to geoscience data and new data analysis tools to greatly increase the productivity and capability of researchers and educators working at the frontiers of Earth system science.

The EarthCube Enterprise Governance Draft Charter was drafted after a careful review of materials created by stakeholders within the EarthCube community. This now requires review and feedback from the EarthCube Community which includes AMS scientists. - <u>EarthCube needs your input</u>!

Each of the following allows you to add your voice. We encourage to you participate in all three:

- 1. <u>Governance Framework Review</u>: provide input on the overall proposed governance framework with this survey, consisting of several strategic overarching questions about the draft charter as a whole (10-20 min.)
- 2. <u>Draft Charter Review</u>: provide in-depth and specific feedback on the charter. This survey consists of a section-by-section review of the draft charter (20-40 min.)
- 3. <u>Strategic Pathway Exercise</u>: help us develop the EarthCube membership model with this short branching survey (5-10 min.)

The <u>EarthCube All-Hands Meeting</u> will bring together project institutions, partners, collaborators, and scientists from across the globe. This meeting will be held from June 24-26, 2014 at the Renaissance DuPont Circle Hotel in Washington, D.C. <u>Register Today</u>!
