## The Chair's Column

### Take the High Road

One challenge to being a conscientious CCM in a competitive economy (which was not invented in 2008) is reacting to a situation in our esteemed profession that involves people not adhering to appropriate professional ethical principles. In demonstrating Character during your journey to become a CCM, you undoubtedly showed familiarity with Article XII in the AMS Constitution, Guidelines for Professional Conduct. Take a moment to refresh yourself on it – the Constitution is on the Administration page on our web site. Do you understand it differently now with added experience? And then, check the articles on ethics in the June, July and November 2012 issues of BAMS, or see the compilation mentioned on [page 2](#), BAMS Ethics Articles, and watch for new articles .



Back to the opening question, how do you react to colleagues, clients, competitors... who do not share your commitment to our chosen field? Your CCM Board and the Society stand ready to advise and assist you with interpreting situations and responding as needed. Are we responsible for the whole profession? My opinion is “maybe”. Minor situations tend to take care of themselves, hoping the collective wisdom of the marketplace tends to cleanse the garden of weeds. Even so, advising AMS of concerns may be important for reasons not obvious. This could be done through the CCM Board if you wish. At the other extreme, someone interfering with proper warning information on weather or environmental situations could need prompt attention if the risk of harm were urgent. Again, AMS and the Board would assist, though contacting an appropriate authority directly may be the best action.

- Fellows



The theme of the 2014 AMS Annual Meeting is “Extreme Weather—Climate and the Built Environment: New Perspectives Opportunities, and Tools.” There will also be 8 short courses offered the weekend prior to the start of the meeting. CCMs receive up to 8 professional development points for attending the meeting and completing a short course (4 point for the meeting, 4 points for a full day short course, 2 points for a ½ day short course). ## NWA Executive Director Stephen Harned, CCM #622 to Retire in 2014

Raleigh, N.C. - National Weather Association Executive Director Stephen (Steve) W. Harned has announced that he will retire effective March 1, 2014. Harned has served as the association's director since 2007.



With Harned's leadership, the association moved from paper publications to full-color electronic versions that gave authors better methods to deliver scientific information. This has better secured the National Weather Association's financial standing. "Steve has been very influential in building bridges between the National Weather Association and other professional organizations and has done extensive work in Washington D.C. to accomplish awareness on issues of importance to the operational meteorology community," stated the Association's President, Bruce Thomas. In retirement, Harned plans to devote more time to golf and to his company, Atlantic States Weather, Inc., which is a meteorological consulting firm based in North Carolina.

Prior to his career as the National Weather Association executive director, Harned had a 36-year career with the National Weather Service where he worked at several offices throughout the U.S. He was the meteorologist-in-charge of the Weather Forecast Office in Raleigh at the time of his retirement in 2004. He is a charter member of the National Weather Association, served as president in 1992 and as the technical editor of the association's National Weather Digest (now the NWA Journal of Operational Meteorology). Additionally he served in the U. S. Naval Reserves for over 25 years and rose to the rank of Naval Captain.

The National Weather Association's nearly 3000 members lead the all-inclusive, 501(c) 6 non-profit, professional association with a mission to

connect operational meteorologists in pursuit of excellence in weather forecasting, communication and service that was established in 1975. Members share information, news, studies and concerns related to operational meteorology and related activities through committee work, articles in National Weather Association publications, the annual meeting and in local chapters. It has local chapters throughout the U.S. and over 35 corporate members. Through generous donations, it offers eight scholarships and one grant for undergraduate and graduate students in atmospheric sciences and related fields. Members also support Sol Hirsch Education Grants for K-12 teachers. The National Weather Association is headquartered in Raleigh, N.C.
