This platform is a versatile and flexible tool, allowing for enhanced committee continuity and will be an excellent resource for new committee members. She recently posted a best practices document for using the platform, which I encourage you to review.

**Note:** You can make the AMS Community platform more useful for your own groups by making a change in the default setting so that you receive any message posted to your Community immediately instead as a morning digest. This is an easy change as follows:

o In your Community of interest, simply click on the "Settings" icon right beside the Community header and change the e-mail notifications to "Real Time." (This is a separate setting in each Community, so you can leave any other Community you are part of set to digest mode if you like.)
